A brief Women of the Church (WOC) report was given by Mary Jane Thompson. The women continue to be active with mission projects especially in Cuba, encouragement, luncheons for women in various regions, and the annual devotional.

Dcn. Barto reminded us that the child/vulnerable adult policy must be followed. Remember...

- -Rule of Two no adult is ever alone with a child; have at least two adults
- -Rule of Three OR one adult and two youth

- -Just because it's hard doesn't mean you are exempt. Must follow.
- -Clergy are mandatory reporters of reported or suspected abuse. Know and follow your state guidelines for reporting.
- -Background checks on all volunteers or staff working with children and vulnerable adults.

Special Guest - Presiding Bishop Ray Sutton. After a short break we returned to our screens for a session of encouragement and updates from our Presiding Bishop who was just back from a visit of the faithful in Croatia and Latvia. In the Trinity season we are reminded from the beginning that the love of God guides and propels our lives and ministries forward in Christ. We preach the gospel of Christ's forgiveness and new life in Him. As we go about our ministry remember that God is raising up a holy remnant in every denomination. The REC and ACNA recognizes and is participating in a new ecumenism occurring among various Christian groups flourishing in the historic Christian faith across the world.

After Bishop Sutton's teaching, the Synod for 2023 was closed in prayer and the bishop gave us his blessing. Synod next year in October in Mason, OH.
