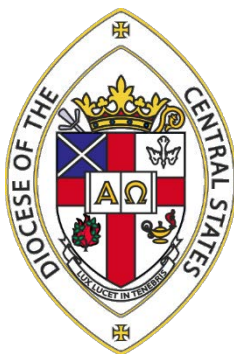

### WEDNESDAY – OCTOBER 15<sup>TH</sup>

Wednesday is a travel day. Opportunity for fellowship and Synod check-in will be available on Wednesday evening with a time of informal gathering and an hors d'oeuvres reception at the hotel from 5:00pm - 7:00pm. Dinner will be on your own. There are several restaurants nearby and within walking distance of the hotel.

*Please note: Those individuals not staying at the hotel do not have to come to the hotel for check-in (unless desiring to do so). They may check-in at the Church on Thursday morning.*

### THURSDAY – OCTOBER 16<sup>TH</sup>

We will officially begin our Synod with Holy Communion at 9:00am on Thursday at Trinity Church in Mason, OH. Our REC Presiding Bishop, Ray Sutton, will be our guest preacher as we observe Oxford Martyr Day.

The Church will open at 8:00am for coffee/tea and continued Synod check-in. Those participating in the service should arrive no later than 8:15am to review logistics with Fr. Jeff Hubbard and to vest. Only those participating in the service will be vesting. A group photo will be taken after the service on the front steps of the church.

Following the Communion service, we will have organizational business and hear Bishop Peter's report. We will then return to the AC hotel for lunch. A box lunch from Izzy's Deli will be provided. Sandwich selections will be made during the registration process. The cost of lunch is included in your full registration cost.

We will remain at the AC Hotel for our afternoon sessions following lunch. Immediately following lunch, we will have an open Q&A with Bishop Sutton and Bishop Manto. We will then hear Mission and Ministry presentations/reports and complete another business session. We will end our Thursday session with said Evening Prayer at 4:45. You will have time to rest and freshen up before our banquet dinner.

The banquet dinner will be at the AC Hotel at 6:30pm. Dress is clericals and Sunday attire. The cost of the banquet is included with your full registration price.

We will begin our Friday sessions at Trinity Church at 9:00am. We will complete any remaining business and adjourn. We will then have a closing Communion Service with Bishop Manto as the preacher. The Certifications of duly elected representatives and statistics is based on the parish certification forms submitted online. I am happy to say that every parish completed the form. All certifications are in order with the following exceptions:

- **Christ the Redeemer – Owensboro, KY** – Ralph Barany was registered as an Observer but was certified as the parish alternate. *Action taken: Changed role to Alternate.*
- **Church of the Holy Cross – Amelia, VA** – Judy Kelly was registered as an Observer but was certified as the parish alternate. *Action taken: Changed role to Alternate.*

There are a total of 77 individuals registered to attend all or a portion of Synod. The following totals of clergy and representatives of the Diocese of the Central States are registered and certified for the purposes of voting at this Synod.

- 2 - Bishops
- 30 – Presbyters
- 17 – duly elected parish delegates
- 0 – Diocesan Officer/Trustee/Standing Committee (*not otherwise elected as a lay delegate*)
- 5 – duly elected parish alternates (*who vote only when their parish delegate is absent*)

In addition to the above voting members of the Synod, there are 23 other individuals registered for at least one portion of the Synod but are not entitled to a vote.

**Synod 2024 Minutes - The Diocese of the Central States**  
**Trinity REC, Mason, OH**  
**October 15-17, 2024**

**Thursday, October 16**

1. After an opening Service of Holy Communion and short break, the Synod was called to order by our Bishop Ordinary, The Rt. Rev. Peter Manto.
2. Based on confirmation from the Registration Desk of those registrants in attendance, a quorum was declared by the secretary, Fr. Keith Boettner.
3. Warm welcomes were extended to all attendees by Bishop Manto and also Fr. Jeff Hubbard, Rector of Trinity Church, Mason. Special welcomes were also extended to all the candidates for the position of Bishop Co-adjutor and their spouses.
4. Greetings were read from our Bishop Emeritus, the Rt. Rev. Daniel R. Morse, who was unable to attend because of health issues. All were encouraged to pray for our dear Bishop Emeritus.
5. Minutes from the 2023 Synod held via Zoom conference had been posted on the Diocesan Website to be read prior to the 2024 Synod. A motion was made by Archdeacon Thompson to approve the minutes without oral reading, seconded, and approved.
6. Committee reports began with Fr. Paul Edgerton, chair of the Nominations Committee. Nominations presented for consideration and vote of the Synod for diocesan positions include: Lay Trustee, Clergy Trustee, Lay Member of the Standing Committee, and Clergy Member of the Standing Committee. A motion was made to accept the entire slate of nominees by group acclamation. The motion was seconded and approved by clergy and delegates present.

7. Bishop Ordinary Report. Archdeacon Thompson was given the chair for the meeting while Bp. Peter Manto gave his report. Bishop Manto repeated his welcome to all Clergy, Delegates, Spouses, Observers, and Candidates and extended a special welcome and expressed what an honor it is to have had our Presiding Bishop, The Rt. Rev. Ray R. Sutton present at our Synod. He remarked that Bishop Sutton has served faithfully in Episcopal office for twenty-five years now. Bp Manto reminded us that he himself was completing his fifth year as our Bishop Ordinary and expressed thanks for all the prayers and encouragement he and wife Janice have received from the Diocese throughout those years. He reminded us that he was, Lord willing, planning to retire sometime after his seventy-fifth birthday.

Fr. Barto is happy to assist any parish with training or a refresher on the policy. Another reminder was given that the C&C require each parish to have books reviewed/verified yearly. A guide/list of best practices for the financial well being of a parish is being developed by Fr. Ken Mills and others will be made available in the future. After a short break, Bishop Manto gave his official consent for the election and the election was held according to the stated canonical and constitutional standards. After deliberation, Canon Jason Grote was duly elected to the position of Bishop Coadjutor of the Diocese of Central States.

A said service of Evening Prayer followed the election.

Later that evening a delicious, joyful Synod Banquet was served and afterward our Presiding Bishop, the Rt. Rev. Ray R Sutton gave an inspiring talk on the life and health of the REC and ACNA, encouraging us all.

## CANON MISSIONER

---

Beloved,

I continue to serve as the National Canon Missioner for the Reformed Episcopal Church. This year I have been asked to be the acting Canon Missioner for the Diocese as Archdeacon Scott Thompson retired at the end of last year. I thank Archdeacon Scott for his work in this role in the past. Serving in this role for the Diocese is intended to be a temporary and transitional one. It is my hope that by Synod 2027, God will have identified and revealed the person He would like to be appointed as the Canon Missioner for this Diocese.

Since this is my first report to you, I may end up overkilling this. But the truth is, I am unaware of how much you may or may not know regarding the various ministries of the national church, including REC100. So I beg your forgiveness because I want to make sure I communicate with you even if it means I risk overcommunicating.

Hopefully you know the name REC100. REC100 is the church planting and revitalization ministry of the Reformed Episcopal Church. It was birthed out of what was originally called “Anglican 1000”. That was the vision of Archbishop Robert Duncan when he called upon the Anglican Church in North America to plant 1000 new missions. Bishop Royal Grote and Bishop Ray Sutton embraced that vision and desired that the Reformed Episcopal Church, as a sub jurisdiction of the ACNA, plant its ‘tithe’ of Anglican1000 – meaning 100 new missions.

Furthermore, the means by which such could be accomplished was through a model of giving that Bishop Royal Grote learned from his involvement with foreign jurisdictions. I believe it was the Diocese of Singapore, but I could be mistaken. In essence, each adult member is asked to donate \$100 to REC100 as a part of their Lenten almsgiving. If each adult were to do this, we would raise over \$550,000 per year based on the 2023 statistical reports. We would raise nearly \$100,000 per year in the Diocese of the Central States alone based on the membership information provided for this Synod. Such levels of support, in DCS, would allow us to plant 2-3 parishes every year between REC100 grants, personal fundraising, and plant offerings.

But the vision, of course, is not simply about numbers or finances. Benchmarks and goals are useful tools but they are not our main objective. It is about the underlying principle of it all which is – ‘go and make disciples of Jesus Christ’. It is about having a mission-al mindset that is ever looking for the opportunities God gives to us to pour ourselves - our souls & bodies, our talents & gifts - into the growth of Christ’s Kingdom through church planting and discipleship. You see, discipleship is not simply about growing and strengthening our own individual relationship with God. True discipleship leads us to the command that we ‘go out’ into the world to order it and establish it – to take of our own self and to share it with the world just as God did when He created all things. That has ever been the call of God from the time He commanded it in Eden, extending to the Upper Room and Olivet when Christ commanded it, and continuing even until the great throne room of Revelation - where we see its accomplishment when all nations and all tribes are brought with one voice and one heart to praise our glorious God! We are ever about Mission.

Now obviously, the implementation of vision takes time. It also takes time for people to embrace the purpose of what we are seeking to do. As of now, we do not have full participation in the offering. Nor

do we have 100 new missions in the Reformed Episcopal Church. However, we continue to move in this direction. Overall, the REC has planted (from scratch) 19 different parishes, three of which were not fruitful (which is perfectly acceptable!). We have also helped to replant four different missions and to provide ministry and/or financial support to four different revitalization efforts. I am also aware of at least seven different parishes, perhaps more, that have transferred into the Reformed Episcopal Church. In total, since its inception in 2017, REC100 has provided over \$400,000 in financial grants. When you think about it - a meager offering of \$100 may not seem like a lot, but it's amazing how far it can go when we all participate together.

### **Lenten Offering**

I can report that the Diocese of the Central States raised its highest annual offering yet! We have received just over \$31,000 so far this year and I'm sure there are a few more parishes who have not submitted their offering yet. Now it's not by chance, but by Providence, that this year's offering is the exact amount for which we are committed in 2025. If you didn't know, we were committed to providing 3 grants totaling \$31,000 during 2025. When we approved these grants, we thought we would have to dip into the reserves of the DCS REC100 fund to cover a portion of them. Yet the 2025 offering has met the entire need! Praise God and may it continue to increase.

I also want to provide offerings by year just so you can see the progression. What I notice right away is that the most dramatic increase started in 2023, 2024, 2025. I whole-heartedly believe that a major contributing factor to this is that it coincides with when the DCS actually started providing grants towards church planting and growth. In 2022, the first grant was provided in the DCS and the offering increased in 2023. In 2023, an additional grant was added and the offering increased again in 2024. In 2024, we had two grants and provided some initial funding for the development of a new planter, and now 2025 sees the largest offering yet. I'm excited for 2026 because we are now providing three grants! In total over these past four years, we have provided nearly \$130,000 in grants and support to DCS plants & missions! Without a doubt, as we have used these offerings towards the growth and care of His kingdom, God has touched the hearts of all our parishioners and increased the resources to meet the need.

Perhaps, if someone has a graphics sort of mind, they could get with me and we could produce a bulletin insert flyer that we could share this kind of information with all our parishes! I would like all our parishioners to know the impact their offering is having on the Kingdom of God.

### **REC100 Retreat**

Just one month ago, REC100 was able to sponsor a week-long retreat for our current and active church planters and their families at a camp conference center in Trinity, TX. Not all families or planters were able to attend, but we still had 19 people from across the country gather for a wonderful time of rest, fellowship, prayer, and learning with each other. Three of our own DCS planters were able to join us (Fr. Andrew Costa, Fr. Alex Marlowe, and Fr. Richard Tarsitano). Our time together was led by Canon Tony Melton, Canon Michael Vinson, and myself. This kind of time being spent with one another in

sharing and heartfelt openness is absolutely vital. It is the hope of REC100 to provide more opportunities like this for our planters.

### **REC100 Cohorts**

REC100 provides an opportunity for planters and revitalizers to join together on a fairly regular basis over Zoom. We call these our REC100 cohorts. Canons Tony Melton and Michael Vinson lead the church planting cohorts. Their wisdom is helpful, both having planted parishes from scratch. And both of those plants are currently in the midst of planting new parishes. Additionally, Canon Tony Welty leads a church revitalization cohort. Canon Tony recently went through a church revitalization process in Shreveport, Louisiana and that parish has flourished. It, too, is currently seeking to plant a new mission locally as well as helping to sponsor a mission 'from afar', as some of their members moved to another state.

### **Always Forward**

I mentioned Anglican1000 minutes ago. That name changed when Archbishop Beach became Archbishop. The name it became was "Always Forward". The inception of Always Forward came at the same time as we were establishing the structures of REC100. As such, the leadership of Always Forward worked together with the leaders of REC100 towards the same goals. Obviously, we have our distinctives, but the wisdom of working together with other church planters and leaders has proven very fruitful. The worry that is often expressed is, "if we work with them, then we'll become like them and we don't want that." That can be true, and great caution should be taken. However, I can say that by working with them they are becoming more like us.

We (meaning myself and Canons Tony & Michael) participate in the Always Forward Canons for Church Planting gathering every year. We did so again this past Spring at the home church of the new Archbishop. This is an opportunity for us to discuss and tackle the challenges that we all face as Canons for Church Planting. We even discuss the problems we face with our Bishops and the Province when it comes to planting. This is to say, that we all have a heart for church planting and trying to find the best ways to support it.

Furthermore, Canon Tony (more than all of us) has been heavily involved with shaping the ministry of Always Forward. He not only helps the leadership of Always Forward, but he also serves as a coach to planters. This means our 'REC guy' is helping to shape new ACNA planters. It's actually because of Canon Tony's involvement that the DCS has our Johnson City plant with Fr. Alex Marlowe and Fr. Mike DuCharme. Likewise, another ACNA planter just recently transferred from his ACNA Diocese into our DSE diocese to plant a new parish. Don't undervalue the impact the REC is having.

### **Church Planting Course**

This year we took a very pointed step in emphasizing church planting, especially as we seek to increase the number of church planters. This past December, Cranmer Theological House launched a new Church Planting course. As Canon Michael said in his report to the Synod of Mid-America last week, "by introducing this much-needed course, Cranmer House is addressing a gap in Episcopal and Anglican seminaries and instilling a missional DNA in our seminarians. The course also provides introductory training in church planting methodology for existing clergy, rectors, and laypersons." The course will be offered again at Cranmer this upcoming February. I encourage anyone interested in church planting to audit this class. It will be available in person in Dallas and by Zoom.

### **Planting Residencies**

Lastly, I wish to mention planting residencies or curacies in established parishes. The desire is to have multiple parishes where a church planter can have a planting curacy for a period of 6-12 months

while actively gathering a group of individuals for a future plant. The initial group may be a cell group of a particular church (or group of churches in an area), or even an interested group from outside a current parish. Additionally, other parishes who may not be ready for a curate, whether for size or financial abilities, will be able to participate as well through other means of support.

This training is not only invaluable for the planter, but it becomes the heartbeat of a parish's mission. One of the questions that often gets asked about growing a parish is, 'what is the best way to grow a parish?'. The desired answer is always for a silver bullet. We all know, however, there is no silver bullet. But I can say that the closest thing you'll get to it is – plant a mission. The testimonies of so many have proven that seeking to plant another mission contributes more to the overall health and growth of the sending parish than most anything else. It's not a magic trick – it's just a matter of culture. When the parish has a culture which is focused on mission – others are naturally brought in.

So I encourage all of you – if you have someone who is contemplating church planting, or if you have a home group or concentration of a couple families in a particular area away from your parish, then please reach out to us. Perhaps REC100 can help partner with you to offer a planting residency.

### **Closing**

Again – I know I spoke for long – but I didn't want to just leave you with the TLDR (too long didn't read) summary of our work together in the Kingdom. I encourage you to share verbal announcements of this information with your congregations, perhaps include snippets in your e-news, or set up a time for me to share this information with your congregation when I start visiting. I know Bishop Manto has done some of that on his visits and I would be happy to do the same when I come around. The more we share together, the more we will be able to accomplish together.

### REPORT OF THE STANDING COMMITTEE

#### ORGANIZATION

##### 2024-2025 Composition

#### ACTIONS

##### **Meetings:**

Most Standing Committee business is conducted via email. In the past year, we met via Zoom on:

1. December 4, 2024—Discussion of consecration and location.
2. December 11, 2024—Discussion of consecration and location.
3. March 3, 2025—Discussion of Bp. Grote's transition to our Diocese.
4. April 9, 2025—Discussion of Bp. Grote's transition to our Diocese.
5. September 4, 2025—Discussion of plans regarding St. Lazarus Mission.

##### **Postulancy:**

1. On December 5 2025, Mr. Tegan Truitt from Holy Trinity, Chantilly VA was approved as a Postulant.
2. On December 5, 2024, Mr. Tucker Holmes from Church of Our Saviour, Oatlands, VA was approved as a Postulant.
3. On February 15, 2025, Mr. Mason Sawyer from All Saints' Raleigh, NC was approved as a Postulant.
4. On March 12 2025, Mr. Jacob Harris from Christ the King, Dayton, OH was approved as a Postulant.
5. In April of 2025, Mr. Noah Elkins from Christ the Redeemer, Owensboro, KY withdrew from the Postulancy to pursue membership in another Communion.
6. On September 3, 2025, Bishop Manto released Mr. Tegan Truitt from the Postulancy at his request. Tegan has moved out of the Diocese to take a job teaching at Grove City College in PA, and may pursue Postulancy in the Diocese of Pittsburgh.

##### **Holy Orders:**

1. On November 4<sup>th</sup> 2024, the Rev. Dcn. Jameson Lowery at Church of the Redeemer in Wilson, NC was approved for ordination to the presbyterate.
2. On January 23, 2025, the Rev. Robert Hudson was received as a retired Presbyterian. He transferred from the now defunct Internation Diocese of the ACNA, and serves at St. Luke's in Maysville, KY.
3. On February 15, 2025, the Rev. Alex Marlowe was received as a Presbyterian into our Diocese to serve as the church planter at the Extension Work in Johnson City, TN (Johnson City Mission). He transferred from the APA.
4. On May 20, 2025, the Rev. Dr. Gerald McDermott was approved to transfer his Orders from the Diocese of Christ our Hope (ACNA) to our Diocese. Dr. McDermott will continue to worship at an ACNA parish in Crozet, VA.
5. On July 21, 2025, the Committee was informed that a letter dimissory was issued by Bishop Manto to the Rev. Dominic Taranto from NC, transferring him to the UECNA.
6. On July 25, 2025, the Committee was informed by Bishop Manto that he had licensed the Rev. Michael DuCharme to serve as Assistant Clergy at the Extension Work in Johnson City, TN (Johnson City Mission). The Rev. DuCharme is an ACNA priest resident in the Jurisdiction of the Armed Forces and Chaplaincy.

**Parish Matters:**

1. On July 25, 2025, Christ Church in Florence, KY was received into our Diocese as a Mission Parish from the APA.

**Calls of Rectors and Vicars:**

1. On July 25, 2025, the Committee affirmed Bishop Manto's appointment of the Rev. Damien Grote as vicar of St. Paul's in Lexington, VA.

**Matters related to Episcopal Election:**

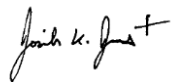
1. As required by Canon 11, the Standing Committee obtained the required consents from the Standing Committees of the Dioceses of the REC after the election of the Rev. Canon Jason Grote as our Bishop Coadjutor. These consents were obtained after providing the required testimonials of the election, and were sent to the Presiding Bishop and Secretary of the General Council on November 20, 2024.
2. On July 25, 2025, in keeping with Canon 16 Section 1 of the REC's Canons, the Committee voted to approve Bishop Grote's absence from the Diocese until he moves here in July 2026. This was a condition discussed before the election last fall, but the Canon makes clear that the SC has to take action to approve the absence of any Bishop from his Diocese that is longer than 3 months.

**Duties as Assigned, and Advice for the Bishop:**

1. On October 24, 2024, I was elected as President of the Standing Committee, by said Committee.
2. In early December 2025, the Committee had a couple of meetings with Bishop Manto to discuss the location and plans for the Consecration of Bishop Grote, which was held June 4, 2025 in Dallas, TX.
3. On February 25<sup>th</sup>, 2025, the Committee approved the Diocesan Clergy Wellness Handbook.
4. In its meeting on April 9<sup>th</sup>, the Committee agreed to the plan to have Bishop Manto appoint the Delegates to the ACNA's Provincial Council.
5. On April 22, 2025, I submitted to the national Constitution and Canons Committee five proposals related to Canon 11 of the REC's Canons. This was submitted on behalf of the Standing Committee. These proposed edits reflect the experience of our Diocese in the election of Bishop Grote, and contain recommendations regarding the number of candidates required by the Canon, moving and deleting sentences which are out of place or no longer relevant, clarifying the Standing Committee's duties after the Search Committee has passed on its recommended candidates, revising the voting process, and deleting or moving other material.
6. On July 25, 2025, the Committee affirmatively rejected Bishop Manto's canonically required resignation. Canon 19 Section 5 (a) and (b) says that upon attaining the age of seventy-five, a Minister is considered to have tendered his resignation on his birthday, unless "affirmatively rejected by a majority of the Vestry, Standing Committee, or General Committee to which the resignation must be offered." By God's Grace, Bishop Manto will serve as Bishop Ordinary until Bishop Grote is installed as Bishop Ordinary at General Council 2026.

**REPORT OF THE BOARD OF EXAMINING CHAPLAINS**

In compliance with the national and diocesan canons, members of the Board of Examining Chaplains are appointed by the Bishop Ordinary and serve at his pleasure. The Board is tasked with examining by written and oral means candidates for the diaconate, presbyterate, and the Order of Deaconesses. The Board as well examines ministers in the process of reception from other churches and selects the annual recipient of the Holy Nativity Seminary Scholarship.

The Board conducts in-person oral examinations the day before each annual Synod. Interim in-person oral examinations and examinations via Zoom may be considered in situations of unusual urgency as requested by the Ordinary.

The curricula and examinations used by the Board are found in the Appendix to the Diocesan Customary.

**Review of Candidates for the Holy Nativity Seminary Scholarship:**

On August 11, 2025 we voted to award the scholarship to Mr. Tyler MacDowell, a postulant at St. Jude's (Richmond, VA), who is studying at Nashotah House.

## **Resolutions to Amend the Canons of the Diocese of the Central States forwarded to Synod by the Constitution and Canons Committee**

Resolution One: To codify the process of receiving clergy from jurisdictions in communion with the Reformed Episcopal Church by adding Section 5 to Title I, Canon I, as follows:

**Section 5.** When a Minister ordained in a Church in communion with the Reformed Episcopal Church desires to be a Deacon or Presbyter in this Church and minister in the Diocese of the Central States, he must apply in writing and present to the Ecclesiastical Authority of this diocese a testimonial letter from the Ecclesiastical Authority of the Church in which he is presently canonically resident, which testimonial fully sets forth his true standing and character. The Ecclesiastical Authority of this diocese may, in its complete discretion, require such additional documentation and examination as necessary to determine whether the applicant should be received. The process of reception should be generally administered in a manner consistent with the canons of the Reformed Episcopal Church applicable to the reception of Ministers ordained in foreign jurisdictions by bishops in communion with this Church. Before a Minister may be received under this canon, his application must be approved by the Bishop Ordinary and Standing Committee.

Resolution Two: To codify the position and duties of Chancellor of the Diocese by adding Canon IX to Title I as follows:

### *Canon IX - Chancellors and Canon Lawyers*

**Section 1.** The Bishop Ordinary may, with the advice and consent of the Standing Committee, appoint a person learned in canon and civil law to serve as diocesan Chancellor. If the person to be appointed is a Presbyter or Deacon, the Bishop may, in his complete discretion, designate him as Canon Lawyer to the Ordinary of the Diocese of the Central States. At the request of the Chancellor or upon his own initiative, the Bishop Ordinary may appoint such Vice or Assistant Chancellors as may be necessary to assist the Bishop or the Chancellor in a specific practice area, jurisdiction, or geographical region.

**Section 2.** The Chancellor will provide such legal advice as permitted by civil law on such matters as shall be referred to him by the Bishop Ordinary, diocesan Synod, Standing Committee, Board of Trustees, Constitution and Canons Committee (if one be appointed), or, with the permission of the Ecclesiastical Authority, any other duly established subdivision, agency, activity, mission, work, or other affiliated entity of the Diocese of the Central States.

**Section 3.** The Chancellor will serve with voice but no vote as a member *ex-officio* of the Standing Committee and the Committee on Constitution and Canons (if one be appointed).

**Section 4.** Any Chancellor appointed under this canon serves at the pleasure of the Bishop Ordinary. Upon the resignation, death, or retirement of the Ordinary, any and all Chancellors shall be deemed to have tendered their resignations to the Standing Committee, subject to the acceptance or rejection of said resignations by the incoming Bishop Ordinary, who shall have the right and discretion to designate such officers.

Resolution Three: To codify the duty of confidentiality in ministry by adding Section 5 to Title IV, Canon 1, as follows:

**Section 5.** Duty of Confidentiality

(A) *Duty*. Except as otherwise provided by this canon, it shall be the duty of every bishop, presbyter, deacon, and deaconess canonically resident in the diocese to maintain the confidentiality of any communication made to that person while acting in a professional capacity as confessor, counselor, or spiritual adviser.

(B) *Limits*. This duty extends only to statements made privately and not intended for further disclosure except to other persons present in furtherance of the purpose of the communication. A threat of violence to a person subject to this duty or a third party is not a “communication” for the purposes of this canon. An otherwise confidential communication may be disclosed at the express request of the person making the communication. In the event a statement made privately would otherwise give rise to a duty to disclose or report under applicable civil law, the recipient of such statement should confer with the Chancellor (if one be appointed) and local counsel to determine his or her obligations under applicable law.

(C) *Extent*. This duty also extends to all persons subject to these canons who have, whether by lawful or unlawful means, acquired knowledge or come to a knowledge of any matter, directly or indirectly, advertently or inadvertently, or in any other way, of that which falls under this canon. Nothing herein shall be construed to limit the privilege law of any applicable jurisdiction. This duty does not terminate upon or with the death of the person making the confidential communication.

## REPORT OF THE COMMITTEE ON MINISTER'S SALARIES

---

There is no official table of suggested salary data provided in this year's report. However, the following information is still provided as general information regarding clergy salaries. For other matters pertaining to Parish Administration and salary guidelines, please consult the Diocesan Customary, the Diocesan Forms of Call, and/or contact the Diocesan office.

**I recommend that parish treasurers consult IRS publication 517 regarding the unique situation of clergy taxation (dual taxpayer status) and the filing of proper tax documents. Clergy on staff should be receiving a W-2 for their salaries and not a 1099, especially if they are receiving a housing allowance. Parishes should not be withholding or reporting any FICA/Medicare wages or FICA/Medicare taxes on clergy.**

Clergy may receive cash compensation which can include a portion that is designated as Housing Allowance. This designation creates a tax benefit for the clergyman. The Housing Allowance must be approved by the Vestry of the parish prior to the allowances being paid. A review of the annual housing allowance designation should be done each November/December during the budgeting process.

Parishes must participate and provide the cost of the Reformed Episcopal Disability policy and defined Pension plan, mandated by the General Council. The current premium for the Disability policy is \$560 per year. This is paid by the Church to the Board of Pensions & Relief on behalf of the clergyman. The plan also provides a life insurance policy. The clergyman does not pay for this premium from his compensation.

Additionally, parishes must contribute 12% of the clergyman's combined salary & housing into the REC national pension plan. Please visit the pensions webpage for contact information, enrollment paperwork, and plan summary information - <https://rechurch.org/bpr.html>

We recommend that rectors be given four weeks paid vacation (including 4 Sundays) annually. An extended paid sabbatical leave should also be considered. The length of sabbatical leave is usually calculated as one week for each year of service since the last sabbatical leave and is taken every four to six years. These items should be determined and enumerated as a part of the minister's contract. Vestries should proactively plan on how to provide coverage while their rector is on sabbatical.

It is also recommended that the Vestry of each parish determine to present a Christmas gift to the pastor. A special appeal should be made to the parishioners and a special offering taken. This gift should be over and above any approved salary/housing.

The parish vestry should provide **an annual review of the pastor's compensation package**. At the very least, a cost-of-living adjustment (COLA) commensurate with the rate of inflation should be provided. If a COLA is not provided, the pastor is, in effect, receiving a reduction in salary.

While the year-over-year level of inflation has continued to decrease, it is still higher than normal. The historic rate of inflations has been as follows:

2021 - 7%.

2022 - 6.5%.

2023 - 3.4%,

2024 - 2.9%.

2025 - 2.9% (as of Sept 23)

It may be impossible for some parishes to provide a COLA adjustment commensurate with these inflation levels, but if parishes do not seek to provide some level of adjustment during these times, they will discover that their current salaries are well below where they should be in a few years.

In such cases when the pastor's compensation is below the guidelines or an increase could not be given at the beginning of the year, it would be most appropriate for the parish vestry to review the financial position of the parish more frequently and determine if increases can be provided to the pastor throughout the year. In some cases, a lump-sum addition can be provided at the end of the year if the parish realizes a year-end surplus.

Parishes should also be mindful of other expenses associated with the ministry of the pastor. Regular reimbursements for hospital parking, personal vehicle mileage (the 2025 IRS rate is now \$0.70/mile), meals with parishioners, and other expenses should be made with accompanying receipts. Please note that mileage cannot be reimbursed on a per mile basis if the actual gas charges are submitted for reimbursement.

In closing, please know that **most pastors will not initiate a conversation or direct the Vestry to consider their own compensation.** If anything, pastors will simply live with 'whatever the parish can do for them', including taking decreases in pay if it helps to balance the church budget. This is often done despite the impact on their own personal and family financial well-being. It should be the regular and normal duty of the Senior Warden to direct the Vestry in these matters and to help care for the pastor and his family. To help with this, we ask that you please provide a copy of this report to your parish Vestry.

**Pulpit Supply** – It should be assumed that a visiting pastor who is asked to cover a worship service and to provide pulpit supply will spend an average of 10-15 hours doing so. They should be compensated for that time along with consideration for how far they are driving. An honorarium should be a minimum of \$200 for their time plus additional for their travel costs if driving any distance. If possible, a parish should strive for a minimum of \$250.00.

A reminder that if a visiting clergyman receives pulpit supply compensation greater than \$599 TOTAL in a given calendar year, then the parish must issue a 1099-NEC to that clergyman.
