MINUTES OF THE 18TH SYNOD

Of The Diocese of the Central States Trinity REC, Mason, OH October 15-17, 2025

Wednesday, October 15

5-7 pm+ - Arrival, Check-in and Registration at AC Hotel in Liberty Center (Mason, OH)

Thursday, October 16

8 am - Remaining check-ins at Trinity Church

9 am - Holy Communion service - Bishop Sutton, preacher

10:45 am - Organization Business and Bishop Ordinary Report

Business items:

1. Credential report was confirmed by Bp. Grote. Each parish and mission of the Diocese was represented. (Report on file on Diocesan Website)
2. Welcome was extended to all by Bp. Peter Manto and also Fr. Jeff Hubbard, Rector of Trinity Church, Mason.
3. Quorum was declared by Fr. Keith Boettner, Secretary of the Synod
4. Bp. Manto presented and welcomed our corresponding members of the Synod: Presiding Bishop of the REC, The Most Rev'd. Ray R. Sutton and also the Rev. Justin and his wife from the Anglican Church of Rwanda. He is currently working in Dayton, OH and is attending and serving at Christ the King Church there.
5. Officers of the Synod. Motion made to accept all the recommended officers. Seconded and approved by the Synod:
 - Bp. Peter Manto - President
 - Bp. Jason Grote - Vice-president
 - Treasurer - Fr. Ken Mills
 - Secretary - Fr. Keith Boettner
6. Minutes from the 2024 Synod were approved by motion, second, and passing vote without reading since they were posted before Synod to be read by all.
7. Fr. Christopher Beckham presented the Nominations Committee Report and Recommendations for Nominees. A motion was made to accept the entire slate of nominees by acclamation. The motion was seconded and approved by passing vote by the Synod.(Report on file)
8. Bp. Grote was given the chair of the Synod while Bp. Manto prepared for his Bp. Ordinary's Report.

9. Bp. Manto then presented his annual report. A motion was made to accept, seconded, and approved by the Synod. (Report on file) Bp. Manto then took back the chair of the Synod at the conclusion of his report.
10. A written message of encouragement from Retiring Archdeacon Scott Thompson was read by the secretary. (On file)
11. A written message of encouragement and support from Bishop Emeritus, Daniel R. Morse was also read to the assembly by the secretary. (On file)
12. The opening organizational session was closed in prayer and participants dismissed for lunch at the AC Hotel.

Thursday afternoon session at AC Hotel - beginning at 1:15 pm

1. Bishop Sutton made his report on the REC's life in the greater Anglican world. We continue to be a much needed traditional, orthodox Anglican influence with/to other groups including the ACNA at-large. It's a time for growth and development worldwide for the orthodox Anglican movement. In addition, Bp Sutton answered questions from Synod attendees on a range of issues.
2. The Rev. Bob Gresser gave the report for the REC Board of Foreign Missions for Bp. John Boonzaaijer who was unable to attend the Synod. He brought greetings from Bp. John to our assembly.
Rev. Gresser reminded us that our God is a missionary God. His first born was sent into a country of prodigals. He also reminded us that our BFM is an important part of our church and serves the church. It is not a parachurch organization. We build REC Dioceses and we send Reformed Episcopalians on missions around the world. He spoke about the success of the Advent offerings this past year in helping to bring cohorts to General Council. The work in Cuba continues to flourish. Rev. Gresser updated us on growing ministries in Croatia and Serbia, Germany, and initial efforts now in Columbia. The BFM is establishing ministers and ministries that are altar centered, community focused, politically astute, and biblically trained and literate. He encouraged parishes to support the BFM in general and also to choose a particular missionary to support if possible.
3. Update on REC 100. Fr. Scott Thompson, Canon Missioner is now officially retired. The work of REC 100 continues successfully. with church planting and revitalization around the world. Offerings are taken in each parish yearly during Advent and Lent to help fund the efforts of these missional-mindset ministries. We are always looking for opportunities to grow the kingdom through church planting and discipleship. All of us are involved and called to support REC 100 with our prayers, participation, and financial support.
4. Fr. John Longcamp from St. Luke's, Florence, KY was welcomed into the Diocese of the Central States. He shared that it was a long road from another jurisdiction to the REC be he's so glad they took it!
5. The ministries of St. Lazarus' Mission was given by Fr. Chris Herman and his wife Carol. They plant churches within Nursing Homes. Fr, Chris becomes a pastor in residence to the people and promises to be their pastor until the pass on. He is present weekly to lead worship in Word and Sacrament, present the love of Christ, and to offer encouragement to a segment of our population that is often forgotten. Liturgy is his catechesis and he

establishes worshipping communities in each facility. He wants to export this ministry into the whole REC and ACNA and is developing a how-to manual to help. (The Society of St. Lazarus.)

With the aging of Boomers, more and more senior adults are living longer and more are entering into assisted living and nursing care facilities. The need is great for this ministry. In fact, he is working on a Doctorate at Fuller Seminary at their initiative and call to help educate and equip the Church as a whole to meet the pastoral needs of our seniors in long-term and nursing care more effectively.

6. Fr. Jonathan Kell announced a Cranmer Extension program developing from his parish in Loudon County, VA. (Church of Our Saviour, Oatlands). To help people within our diocese to be trained and equipped for ministry, they will be offering weekend intensive classes at the parish. He extended an invitation for anyone in the Diocese to contact him to be able to participate.
7. Fr. Brian Foos gave a presentation on the new St. Andrews Anglican micro-college that has developed from his parish and school in Northern California (Lake Almanor). Pamphlets, information, and some merchandise were made available. His daughter Emma was their first graduate. Emma gave an inspiring testimonial of her experiences and shared her confidence and hope in the great work that God is doing in their midst.

Friday Morning - 10/17/25 - Concluding Business - 9 am at Trinity Church, Mason, OH

1. Bishop Jason Grote gave his Co-adjutor report. Motion, second, report accepted. (Report on file)
2. Fr. Josiah Jones (President of SC) gave the Standing Committee Report for the year. Motion, second, report accepted. (Report on file)
3. Fr. David Goodwin and Fr. Ken Mills gave the Trustees Report. Motion, second, report accepted. Fr. Ken shared a quick overview of the Lilly matching funds program for Clergy Wellness. At that time, we were the only diocese to receive disbursement. The grant is given to the ACNA in general, not directly to the REC. Motion, second, report accepted. (Report on file.)
4. Examining Chaplains Report - Fr. Paul Edgerton. Fr. Paul reminded us to be praying for the chaplains regularly. Motion, second, report accepted. (Report on file)
5. Constitution and Canons Committee Report - Fr. Bill Barto.

Resolution One: To codify the process of receiving clergy from jurisdictions in communion with the Reformed Episcopal Church by adding Section 5 to Title I.

Resolution Two: To codify the position and duties of Chancellor of the Diocese by adding Canon IX to Title I.

Resolution Three: To codify the duty of confidentiality in ministry by adding Section 5 to Title IV, Canon 1.

Motions, seconds, acceptance for all three resolutions on file as presented. (Report on file.)

6. Setting date of next Synod to coincide with General Council in June 2025. General Council is set for June 10-12, 2026 in Richmond, VA. We propose having a brief Synod on June 9 at St. Jude in the afternoon. Motion, second, approved by the Synod.
7. Motion to adjourn. Seconded and approved.

8. Synod was closed with a service of Holy Communion. Bishop Manto, preacher. All participants were dismissed around 12 Noon.

BISHOP COADJUTOR REPORT

Dear Brethren,

At this abbreviated Synod, I offer this brief report as a summary of key diocesan developments in which I have participated, as well as my trips, activities and official acts since our last synod in October 2025. Some of these are reported by others as well.

Clergy Wellness Ministry

I reported last October that I would like our diocese to continue developing a robust way of providing wellness, health, and development for our clergy and their families. There is much work to be done, but initial steps and planning have taken place. Fr. Damien Grout, Fr. Davidson Morse, and I have been working together, and the Standing Committee has voiced their support, for this endeavor. Fr. Damien will speak more directly about this.

Cranmer House Extension – Leesburg, VA

Our diocese has expressed a desire to provide in-person seminary classes within our own geographic regions. I am proud to report that our initial plans are coming to fruition. Under the direction and leadership of Fr. Jonathan Kell the first class was offered just a few weeks ago in May with a second already scheduled. Fr. Kell will speak more directly about this. I would like to see us duplicate this model in the Ohio-Valley Deanery in future years. Here's a couple of pictures from the most recent class.



DCS Website

I am pleased to announce that the diocese is getting a new website. After many gracious and faithful years of Mr. Andy Figueroa donating his time and service, the Trustees approved Garden City Media as the new webmaster for the DCS. I had an initial meeting with GCM in May, and they should have the

project completed by the end of August. If you would like to see an example of their work, you can look at the new REC website which was published a few weeks ago. I am also working with GCM to coordinate free non-profit resources with Google that will allow the DCS to have a centralized “server” for file-storage, document sharing, diocesan teams, and other tools that will help with communication and administration within the diocese.

Incorporation of the Diocese & Exemption Status Declaration

With the input of our Chancellor and the approval of the Standing Committee and the Trustees, I worked with Fr. Ken Mills to officially incorporate the Diocese. Fr. Ken officially filed and received the corporation certificate from the Commonwealth of Virginia. Fr. Ken is now working on the IRS submission for official recognition as an exempt organization. While we currently fall under the exemption of the national church, it is important that we seek our own exemption status as a diocese.

Investments

At the direction of the Trustees, I worked alongside Bishop Manto, James Moose, and Fr. Ken in researching an opportunity for the diocese to open an investment account with Ms. Kim Winans, financial advisor with Edward Jones. Ms. Winans serves as a financial advisor for many of our denominational entities. This opportunity was discussed and presented to the Trustees, who approved opening an account.

General Council

This year’s General Council is a special one for the Diocese of the Central States. It is the first time the DCS is hosting a General Council!! Additionally, Bishop Peter will transition his office of Diocesan Ordinary to me as I am installed at the opening eucharist service. As Program Committee chairman, I oversee the planning and coordination of this council. I give special thanks to those from the DCS who have labored with me to coordinate this council – especially Bp. Peter, Archdeacon Scott Thompson, Fr. Bart Gingerich, Fr. Ken Mills, the volunteers of St. Jude’s and Holy Cross, and the residents of Chesterfield Heights.

Trip & Activities

- Treasurer of the Board of Foreign Missions (*continuing*)
- Webmaster for the Denomination (*transitioned already*)
- Webmaster for the Diocese of Mid-America (*transitioned already*)

Family & Moving Update

I offer a brief family & moving update. My daughter, Avery, just graduated high school in May. She will remain in Texas to attend Texas A&M. My son, Aidan, is relocating with Liz and I to Ohio. He has been accepted to Cedarville University and will commute from our new home. We have a contract on my house in Texas and we are scheduled to close just prior to this Synod. We will remain in Texas until my last Sunday at my current parish (June 28). We will drive to Ohio and reside in temporary housing until our new home in Xenia, OH is completed. We are expected to close on August 3rd (but hopefully sooner). I will take the month of August to get myself fully settled and will then resume travels and visitations in the Fall.

Closing

In closing, I wish to thank Bishop Peter for his support from the time of my election and leading up to the installation service tomorrow. Bishop Peter and Janice have been incredibly welcoming and supportive throughout this whole process of transition and moving. He shares the responsibilities of leading the diocese with me, includes me in important decisions, and provides wisdom and understanding as I make various decisions. I was most amazed when he and Janice, unprompted by me, drove an hour out of their way to the area where my family is purchasing a home and where my son will be attending college. They did this so they could talk to our future neighbors and assess what things we might need to consider. Thank you Bishop Peter and Janice for such love. I only hope I can emulate that kind of care as I minister to those the Lord is entrusting to me. I know you are not going anywhere and will still walk with me during this transition and beyond, but I do pray that you and Janice can relax and enjoy a little bit more time in retirement.

Finally beloved, I will always end my report by asking of you the same prayer that I asked when I was elected - "Pray for my wisdom". Pray that I will be faithful in my oversight and that I will always lead you according to His blessed will and ordinance.

Future Plant Being Planned

Fr. Jonathan Kell is leading Church of our Savior at Oatlands in Leesburg, VA through a planning phase for a new church plant. This daughter congregation will be planted in the surrounding area of Washington DC. REC100 is already committed to providing an initial \$10,000 grant towards this effort. This is your Lenten Offerings at work. Please pray for Church of our Savior, Fr. Jonathan, and all those involved who are working towards this next great parish!

Canon Missioner

I will be actively looking to appoint a new Canon Missioner within the Diocese before our next Synod (Oct 2027). This individual (lay or clergy) will be one who has a vision and strategic mind for establishing plans. Yet they must not simply be a glorified business administrator or entrepreneur. They must be committed to the true purpose of planting churches, be attentive to the needs of church planters, and be sensitive enough to embrace differences between geographic cultures, as well as understanding that not everything in ministry is black and white or always has to follow the same checklist of do's and don'ts. It really takes a little bit of everything. If you have suggestions of individuals (again – lay or clergy) that you think might excel in this role, please let me know so I can consider them. Most importantly - please be in prayer as I discern the Lord's will for this over the next year.

REPORT OF THE BOARD OF TRUSTEES

Diocesan Synod, June 2026

Submitted by Fr. David Goodwin, President

The Board of Trustees met in regular session on November 11, 2025, February 3, 2026, and April 28, 2026. All meetings were conducted via Zoom. Bishops Manto and Grote were present at each meeting, along with Fr. Ken Mills (Treasurer), Fr. Keith Boettner (Secretary), and the Trustees.

Fr. Ken will give the financial report. The Diocese continues to enjoy sound financial health.

Diocesan Incorporation

Following a recommendation reviewed and approved by both the Chancellor and the Standing Committee, the Trustees voted unanimously to incorporate the Diocese. We have now incorporated the Diocese in the Commonwealth of Virginia. Fr. Ken is working on the corporation's own 501(c)(3) nonprofit designation. We are already a nonprofit organization because we are a church and are under the umbrella of the REC; however, having our own designation makes certain matters easier, particularly when anyone wishes to make a donation directly to the Diocese.

Clergy Wellness Fund

The Trustees approved the revised Clergy Support Handbook. The Board has also acted on two requests for assistance from the Clergy Wellness Fund during this period, approving support for clergy and their families facing a significant financial need. The Trustees are committed to exercising prayerful care and appropriate confidentiality in administering this fund. You can find the appropriate procedures on the Diocesan website; if you prefer, you can contact Fr. Ken or me, and we'll help you with the forms.

New Financial Adviser.

Because we have exceeded our FDIC insurance limit at our bank and now oversee a large portfolio of Diocesan funds, the Trustees decided it is appropriate to seek the assistance of professional money managers. The Trustees approved the opening of an account with Edward Jones and will begin moving funds to them soon.

Edward Jones is a long-established financial services and investment firm founded in 1922 and headquartered in St. Louis, Missouri. The company is known for its conservative, relationship-based approach to investing, emphasizing long-term stewardship, personalized financial guidance, and adviser service rather than speculative trading. Edward Jones also serves as an adviser to the REC and the Diocese of Mid-America.

The firm will serve as custodian and adviser for diocesan funds, offering investment management, CD laddering, cash management, and diversified portfolio strategies designed to balance preservation of capital, liquidity, and prudent long-term growth.

New Trustees

The Board welcomed two new members: Fr. Damien Grout (St. Paul's, Lexington, VA) and Mr. James Moose (St. Luke's Anglican Church, Maysville, KY).

REPORT OF THE BOARD OF EXAMINING CHAPLAINS

In compliance with the national and diocesan canons, members of the Board of Examining Chaplains are appointed by the Bishop Ordinary and serve at his pleasure. The Board is tasked with examining by written and oral means candidates for the diaconate, presbyterate, and the Order of Deaconesses. The Board as well examines ministers in the process of reception from other churches and selects the annual recipient of the Holy Nativity Seminary Scholarship.

The Board typically conducts in-person oral examinations the day before each annual Synod. Interim in-person oral examinations and examinations via Zoom may be considered in situations of unusual urgency as requested by the Ordinary.

The curricula and examinations used by the Board are found in the Appendix to the Diocesan Customary. The Board of Examining Chaplains comprises:

Examinations of Candidates for the Diaconate:

Mr. Kevin Gottlieb applied for the Diaconate and submitted his written examination, which the chair received on September 1, 2025. We conducted the oral portion of the examination via Zoom on October 11. The chair reported our assessment of the candidate's preparation that evening.

Mr. Thomas Caucutt applied for the Diaconate and submitted his written examination, which the chair received on January 6, 2026. We conducted the oral portion of the examination via Zoom on January 27. The chair reported our favorable assessment of the candidate's preparation for Orders on January 29.

Examination of Candidates for the Presbyterate:

None to report for this period.

Examination of Candidates for the Order of Deaconesses:

None to report for this period.

Review of Candidates for the Holy Nativity Seminary Scholarship:

On March 24, 2026, we announced our vote to award the scholarship to Mr. Caleb Symons, a student at Church of Our Saviour Oatlands (Leesburg, VA), who is studying at Cranmer Theological House.

Other Matters:

This fall, attention was given to the reporting procedures the Board has used since the diocese's founding and ways that we can bring those procedures into better alignment with diocesan canons and better reflect the nature of our examination process.

We pray for the raising and forming of men and women who will serve well in the ordained and consecrated ministries of the diocese. And we thank our bishops for the privilege to serve in this manner.

CONSTITUTION & CANONS

The following canonical changes are recommended to the Council for adoption.

Title I, Canon VIII, Section 1, currently reads as follows:

Section 1. The following organizations are recognized as authorized agencies of the Diocese of the Central States and are entitled to representation in the Synod of the Diocese of the Central States under Article V, Section 2, of the Constitution:

- (A) The Reapers
- (B) The Women of the Church
- (C) The Men of the Church
- (D) Cranmer Theological House

Title I, Canon VIII, Section 1, is revised to read as follows:

Section 1. Upon the recommendation of the Bishop Ordinary and the Standing Committee, the Synod of the Diocese of the Central States may designate organizations that further the mission of the Diocese as authorized agencies of the Synod, entitled to representation in the Synod under Article V, Section 2, of the Constitution.

Basis for the Proposed Change: Section 1 as currently written refers to organizations and agencies not active in the Diocese of the Central States. The provision may have been mistakenly included in the original canons, which were based upon the canons of the Diocese of Mid-America. The proposed revision clarifies the authority of the Synod to recognize such organizations and also provides for involvement of the Bishop Ordinary and the Standing Committee in any such recognition.

Title II, Canon IV, Section 3, currently reads as follows:

Section 3. The Communicant list shall be corrected annually by the Parish Council by removing from active membership, through notation, the names of all persons who have died, have been ordained to the Presbyterate, dismissed to another church, excommunicated, together with those who for a period of one year have not partaken of the Lord's Supper, disappeared, ceased to attend Divine Services, or to contribute to the support of the Parish; provided that all reasonable efforts to reclaim such members have been made.

Title II, Canon IV, Section 3, is revised as follows:

Section 3. The Communicant list shall be corrected annually by the Parish Council by removing from active membership, through notation, the names of all persons who have died, have been ordained to the Presbyterate, **made Deacon**, dismissed to another church, excommunicated, together with those who for a period of one year have not partaken of the Lord's Supper, disappeared, ceased to attend Divine Services, or to contribute to the support of the Parish; provided that all reasonable efforts to reclaim such members have been made.

Basis for the Proposed Change: Deacons are subject to the authority and direction of the Bishop Ordinary and are not members of any particular parish. The proposed change clarifies the responsibility of the Parish Council to remove those made Deacons from the parish Communicant list.

Title III, Canon I, Section 3.6, currently reads as follows:

Except in the case of an Interim Rector, the Letter of Call or Contract must be for a period of two years.

Title III, Canon I, Section 3.6, is revised to read as follows:

Except in the case of an Interim Rector, the Letter of Call or Contract must be for a period of **at least** two years.

Basis for Proposed Change: The current canon anticipates that the Letter of Call or other written contract for a Rector, the calling of a Presbyter, the appointment of a Vicar, and the assignment of a Deacon/Deaconess "must be for a period of two years." In practice, the provision is often omitted or ignored. The proposed change will allow parochial discretion to increase the term of call while retaining the current specified term as the minimum duration of a call, appointment, or assignment, except in the case of an interim Rector.
